Each Parish Council is to decide how they charge for their magazine, if at all, but a cover price of 50p will be put on future magazines as a guide. The Chairman thanked Nick and the team for all their hard work.

249.4 Minutes: The Minutes of the meeting held on the 20th March were approved and signed as a true record. **Matters Arising: 248.9.1: Airband** have completed a second survey of The Moorland Hall and found it suitable for their free broadband: Cllr Clarbull is progressing.

249.6 Highways: <u>Draper's Way</u>: Co Cllr Nicholson gave an update on the proposed works which will entail a full road closure for 6/8 weeks around October, includes reinforcement of the bridge parapet and tree works. Cllr Anson has contacted local residents to see how disruption can be minimized. <u>Road Signs:</u> Cllr Webber stressed that the positioning to indicate road closures and diversions needs improvement: Co Cllr Nicholson thought that the compilation of a database of suitable positions would be useful. <u>Potholes on B3224 just before Kennisham Wood</u>: Cllr Anson to report to Highways. <u>Dog Fouling Signs</u>: the Clerk agreed to produce some new ones. <u>SIDS Report</u>: The Clerk

circulated her report to all present: this outlined the current options (copy filed with these minutes): it was agreed to adopt her suggestion of setting up a working party to move things forward: Cllrs Clarbull and Norman agreed to do this. The Clerk to ask Highways if the 106 money remaining from the housing development may be spent on a SID for Cutcombe.

- **249.7 Wheddon Cross Toilets:** The Clerk read out Cllr Atkins' report on the toilets and added that the mosaic and the roof have also now been cleaned and the requisite insurance is in place. On the advice of the building inspector there will not be rails on the ramp leading up to the disabled toilet. The overhanging tree: WS Cllr Pugsley agreed to find out if there is a cost involved in getting this assessed for safety.
- **249.8 Finance: 8.1** It was agreed to pay £200 retrospectively to John Davis for trailer hire during the Snowdrop Valley Park and Ride Scheme **8.2** Agreed to pay £26.18 to Southern Electric (retrospective) for standing charge at the WX toilets **8.3** Agreed to pay the Moorland Hall £11 for February and £11 for March room hire **8.4** Agreed to pay Eagle Plant £31.68 for March Heras fencing hire and their final invoice for £31.20 to end of hire **8.5** Agreed to pay £341 to Somerset County Council for road closure for Snowdrop Valley: ENPA has agreed to reimburse Cutcombe PC for this cost **8.6** Agreed to pay additional SV wages of £103.40 **8.7** Agreed to pay Inland Revenue tax due of £16.60 (these last two items due to an error in pay rate at the initial payment stage)
- **249.9 Correspondence and Meetings: 249.9.1** The Clerk reported that her letter to *The West Somerset Free Press* thanking all those involved in the Snowdrop Valley Park and Ride Scheme had been published. **249.9.2** Cllr White reported on a meeting at ENPA which included the leaving of David Wyborn, Chief Planner. Co Cllr Nicholson reported on Adult Social Services including the Micro Provider Scheme and Developed Transfer Care. WS Cllr Pugsley reported that the Secretary of State has agreed that the West Somerset/Taunton Deane merger can go ahead, there will be significant ward changes.
