2. 227.4 Minutes: The Minutes of the meeting of 17th May were approved and signed as a true record with one amendment: Cllr Webber had been chairman for 28 years not 35. Matters Arising: 226.1 Cllr Webber thanked Cllr Atkins for all her help and support during her years as Council's Vice-Chairman. 226.7 The Clerk reported that the Directors of Exmoor Farmers Auctions have a meeting next week and will report back to her re the self-build plots at the market site.

227.5 227.5.1 Planning Application: 6/8/16/106 Allercott Farm: Proposed installation of a mobile telecommunications pole and ancillary equipment (12m high timber telegraph pole above ground, supporting radio equipment and cabinet): fully

Water Main from <u>Meadow Close to Knapp Cottage and beyond:</u> further repairs have been necessary: the Clerk asked to write to Wessex Water asking if the whole main can be replaced and to complain about the state in which Luckwell Bridge was left after the replacement of the main there. Luckwell Bridge: Cllr Nicholson reported that the bridge monitoring team regularly check the bridge but she will follow up residents' concerns especially in the light of large lorries using the bridge. <u>Cctv cameras at the car park</u>: the Clerk to send off the Police Commissioner's Project Monitoring Form asap and to arrange a meeting for Monday 11th July for publicity re the cameras.
